Service
<u>Discovery</u> : Answer or propound interrogatories and requests for production of documents, prepare and service subpoenas
<u>Motions</u> : Contempt of parenting plan or child support; Enforce, clarify, or vacate orders; Reconsideration or revision of a commissioner's ruling; Change venue; Adjust child support
<u>Trial Preparation</u> : Prepare trial brief, exhibits, property spreadsheet, trial notebook, and/or proposed orders
<u>Mediation Preparation</u> : Prepare mediation statement, exhibits, property spreadsheet, proposed orders, and/or proposed settlement agreement
